SUMMARY OF THE PROCEEDINGS OF THE 24TH ANNUAL GENERAL MEETING

The 24th Annual General Meeting (AGM) of the Shareholders of Sonata Software Limited was held at 4.00 p.m. on Wednesday, the 7th day of August, 2019 at M.C.Ghia Hall, Bhogilal Hargovindas Building, 18/20, Kaikhushru Dubash Marg (behind prince of wales museum), Mumbai – 400 001, Maharashtra.

Mr. Pradip P Shah, Chairman, took the Chair and welcomed the Members to the 24th AGM of the Company. The Chairman declared the meeting as validly convened, since the requisite Quorum was present. The Members were informed that the requisite registers and the documents referred to in the Notice of 24th AGM were available for inspection during the Meeting.

Mr. Pradip P Shah, Chairman addressed the members followed by a presentation by Mr. P Srikar Reddy, Managing Director and CEO.

Further, the Chairman informed that the Company had provided the Members the facility to cast their vote electronically, on all resolutions set forth in the Notice. Members who were present at the AGM and had not cast their votes electronically were provided an opportunity to cast their votes at the end of the meeting. It was further informed that there would be no voting by show of hands.

The following items of Business, as per the Notice of AGM dated May 30, 2019, were transacted at the Meeting:

Ordinary Business:

- 1. Adoption of Financial Statements for the Financial Year 2018-19 (Including the consolidated Financial Statements);
- Confirmation of the payment of Interim Dividend of Rs. 4.75 per equity share (i.e. 475%) already paid and declare Final Dividend of Rs. 8.00 per equity share (i.e. 800%) for the Financial Year 2018-19;
- 3. Appointment of a Director in place of Mr. Viren Raheja (DIN: 00037592), who retires by rotation and being eligible, offers himself for re-appointment; and

Special Business:

- 4. Special Resolution for appointment of Mr. Pradip P Shah as an Independent Director;
- 5. Special Resolution for appointment of Ms. Radhika Rajan as an Independent Director





The queries raised by the members were clarified. Mr. Parameshwar Bhat, Practicing Company Secretary (FCS- 8860/ CoP No- 11004) was appointed as the Scrutinizer to scrutinize the voting process in a fair and transparent manner.

The members were informed that the consolidated results of the remote e-voting and the Poll will be declared on receipt of Scrutinizer's report and placed in Company's website and sent to the Stock Exchanges.

The AGM concluded with a vote of thanks to the Chair.
