High-profile hospitals like <u>King's College Hospital NHS Foundation Trust and Guy's and St Thomas' NHS Foundation</u> Trust have recently faced crippling cyber incidents, exposing millions of medical devices to ransomware attacks.

An alarming reality: <u>24% of hospitals</u> globally reported higher mortality rates post-cyberattacks. The devastating 2017 "<u>WannaCry</u>" ransomware attack cost the NHS £92 million and canceled 19,000 patient appointments.

UK healthcare providers also grapple with stringent compliance requirements from the CMA and PHIN, adding complexity to the reporting processes.



# Why Move Away from Legacy Infrastructure?

Meeting CMA and PHIN reporting mandates with legacy systems is nearly impossible, requiring manual, error-prone workarounds that consume valuable time and resources. Failure to comply risks significant fines and burdensome paperwork for UK private healthcare companies.

Also, healthcare organizations are becoming prime targets for cybercriminals. Globally, 60% of healthcare organizations faced cyberattacks last year, with only 24% disrupting ransomware before data encryption.


